COMMUNICATION PROTOCOLS WITH CONTRA COSTA COUNTY

RE: CCC Communication Protocols Concerning Diablo Land Use and Zoning

I. Background

The Diablo Municipal Advisory Council (DMAC), established by the Contra Costa County Board of Supervisors in the late 1990s, represents the Diablo community to the Contra Costa County Department of Conservation & Development in matters pertaining to planning and zoning. DMAC's authority is advisory and has no binding authority. Specifically, the County Board of Supervisors granted DMAC the following authority under CCC Resolution No. 2006/791, which was then extended at the December 16, 2008 CCC Board of Supervisors' Board Meeting:

II. MAC External Communication and Representation (from 2008 mtg):

MACs advise the Board of Supervisors on land use and planning matters affecting their communities of interest and may represent their communities before the Board of Supervisors, the Planning Commission and the Zoning Administrator on such issues as land use, planning, and zoning. MACs may also represent the community before the Local Agency Formation Commission on proposed boundary changes affecting the community.

MACs may advise the Board of Supervisors on services which are or may be provided to the community by Contra Costa County or other local government agencies. Such services include, but are not limited to, public health, safety, welfare, public works, and planning. MACs may also provide input and reports to the Board, County staff or any County hearing body on issues of concern to the community.

However, it is understood that the Board of Supervisors is the final decision-making authority with respect to issues concerning the community and that the Council shall serve solely in an advisory capacity.

In 2006, at the request of the County Board of Supervisors, DMAC's advisory work became the responsibility of the Diablo Community Services District (DCSD) Board. Separate meetings would be held, and all County communication concerning zoning and planning within Diablo would be through DMAC.

In 2002 the Diablo Historical Preservation Committee, (DHPC), a self-appointed volunteer subcommittee of the Diablo Property Owners' Association (DPOA), a self-appointed volunteer organization, filed a petition with the County to have certain homes in Diablo flagged as Historical. Furthermore, the DHPC asked that any land use permits requested by these properties be forwarded by the County to DHPC for review and comment. The following homes have been identified as historical (homes identified as torn down or substantially torn down are no-longer deemed historical):

The addition of the Historical Homes and the land use review request by DHPC has created confusion for the County planners and frustration for residents trying to understand the permit process.

II. Proposed Communication Protocols Between the County and DMAC

DMAC, following discussions with the County, is proposing the following communication protocols be established between the Contra Costa County Department of Conservation & Development and DMAC to eliminate the confusion and frustration:

1. All land use, planning matters and services, such as zoning, boundaries, public health, safety and public works impacting the community of Diablo will be communicated to DMAC via email to *generalmanager@diablocsd.org*. If USPS mailing is required, communication will be sent to DMAC, PO Box 321, Diablo, CA 94528.
2. DMAC has the authority to design/define notification review processes within Diablo, including use of other committees or persons with expertise on particular land use or planning matters. However, DMAC is the only organization authorized to respond to/advise the County on such matters.

III. Recommended Action and Motion

Recommended action is as follows: the DMAC Board adopts the communication protocols listed above and formalizes the procedures in a letter to be sent to the Contra Costa County Department of Conservation & Development with a copy to Alicia Nichols, liaison to Supervisor Diane Burgis.

DMAC's internal review procedures using assistance from the community should be reviewed and clarified separately from communication with the County.

CALL TO ORDER: President Kathy Urbelis called the meeting to order at 8:08 p.m.

DISCUSSION:

Daniel Barrios, Senior Planner and Sean Tully, Principal Planner, with the Contra Costa County Department of Conservation and Development presented Envision 2040 and the proposed zoning (land use map) update for Diablo. Mr. Barrios indicated that the updates to the general plan do not impact Diablo. Director Eorio asked if the zoning changes would impact the 1/2-acre minimum requirement for development in lower Diablo. Mr. Barrios stated that the zoning changes to the land use designations impacting Diablo were made to reduce confusion and are not likely to impact development ordinances within Diablo. Envision 2040 is scheduled for completion at the end of 2022. ACTION ITEMS:

Alicia Nuchols, District Representative for CCC Supervisor Diane Burgis, presented to the Board the DMAC 2020 Annual Report and 2021 DMAC Objectives document prepared by her in conjunction with President Urbelis and the General Manager. The annual review and adoption of the MAC's activities and goals is a County requirement.

Director Eorio presented his review and proposed comments on the proposed site plans for the development of Parcel B located on Avenida Nueva (between Calle Los Callados and La Cadena). A staff report detailing the review and recommendations was included with the agenda.

The Directors in attendance unanimously agreed that the site plan proposed is acceptable subject to the conditions identified in the staff report. President Urbelis will work with the General Manger to prepare a response to the County.
